- Upon considering :
- a. whereas in the light of preparing the transition of rehabilitation and reconstruction activities in Nanggroe Aceh Darussalam Province and the Islands of Nias of North Sumatra Province, it is deemed necessary to establish Joint Secretariat for Rehabilitation and Reconstruction Activities of the Regions and the Life of People of Nanggroe Aceh Darussalam Province and the Islands of Nias of North Sumatra Province;
 - b. whereas in order to execute the activities as referred to in alphabet a, it is deemed necessary to enact the personnel of Joint Secretariat for Rehabilitation and Reconstruction Activities of the Regions and the Life of People of Nanggroe Aceh Darussalam Province;
 - c. whereas the named individuals as which contained in this Decree are deemed fit and proper to carry out their duties in Joint Secretariat for Rehabilitation and Reconstruction Activities of the Regions and the Life of People of Nanggroe Aceh Darussalam Province;
 - d. whereas based on considerations as referred to in alphabet a, alphabet b, and alphabet c, it is necessary to enact Joint Decree of Head of Executive Agency and Governor of Nanggroe Aceh Darussalam concerning Joint Secretariat for Rehabilitation and Reconstruction Activities of the Regions and the Life of People of Nanggroe Aceh Darussalam Province.

HAS DECIDED:

- To enact : **JOINT DECREE OF HEAD OF EXECUTIVE AGENCY AND GOVERNOR OF NANGGROE ACEH DARUSSALAM CONCERNING JOINT SECRETARIAT FOR REHABILITATION AND RECONSTRUCTION ACTIVITIES OF THE REGIONS AND THE LIFE OF PEOPLE OF NANGGROE ACEH DARUSSALAM PROVINCE**
- FIRST : To enact Joint Secretariat for Rehabilitation and Reconstruction Activities of the Regions and The Life of People of Nanggroe Aceh Darussalam, which consists of Advisory Team and Executive Team with personnel as referred to in annex of this Decree;
- SECOND : Joint Secretariat as referred to in FIRST dictum is tasked:
- a. to prepare Transition Strategy and Mechanism of Transfer of Duty and Responsibility in Rehabilitation and Reconstruction in the Region of Nanggroe Aceh Darussalam to Regional Government before the forthcoming end of duty of Agency of Rehabilitation and Reconstruction of the Regions and the Life of People of Nanggroe Aceh Darussalam Province and the Islands of Nias of North Sumatra Province;
 - b. to compile and formulate correct policies in cooperation in order to promote rehabilitation and reconstruction of the region and the life of people of Nanggroe Aceh Darussalam Province;
 - c. to execute coordination, synchronization, integration, evaluation and cooperation in conducting rehabilitation and reconstruction programmes;
 - d. to decide on role sharing among actors of rehabilitation and reconstruction of the region and the life of people of Nanggroe Aceh Darussalam;



- e. to provide planning document and budget information transparently;
- f. to conduct socialization, dissemination and distribution of data and information relevant with rehabilitation and reconstruction planning strategy to stakeholders in local, national and International level;
- g. to decide on a mechanism to mobilize all funding sources (APBN, APBD Provinsi/Kabupaten/Kota and Donor Support) and their distribution so that they become more transparent, effective, participative and accountable.

THIRD

- : Advisory Team as referred to in FIRST dictum is tasked:
- a. to decide on policies relevant with Transition Strategy and Mechanism of Transfer of Duty and Responsibility in Rehabilitation and Reconstruction in the Region of Nanggroe Aceh Darussalam to Regional Government before the forthcoming end of duty of Agency of Rehabilitation and Reconstruction of the Regions and the Life of People of Nanggroe Aceh Darussalam Province and the Islands of Nias of North Sumatra Province;
 - b. to steer Executive Team in compiling and formulating correct policies in cooperation in order to promote rehabilitation and reconstruction of the region and the life of people of Nanggroe Aceh Darussalam Province;
 - c. to steer Executive Team in executing coordination, synchronization, integration, evaluation and cooperation in conducting rehabilitation and reconstruction programmes;
 - d. to steer Executive Team in deciding the role sharing among actors of rehabilitation and reconstruction of the region and the life of people of Nanggroe Aceh Darussalam and the islands of Nias of North Sumatra Province;
 - e. to steer Executive Team in deciding the mechanism to mobilize all funding sources (APBN, APBD Provinsi/Kabupaten/Kota and Donor Support) and their distribution so that they become more transparent, effective, participative and accountable;
 - f. to become main responsibility holder for all success of execution of duty and responsibility of Joint Secretariat.

FOURTH

- : Executive Team as referred to in FIRST dictum is tasked:
- a. to prepare the concept of Transition Strategy and Mechanism of Transfer of Duty and Responsibility in Rehabilitation and Reconstruction in the Region of Nanggroe Aceh Darussalam to Regional Government before the forthcoming end of duty of Agency of Rehabilitation and Reconstruction of the Regions and the Life of People of Nanggroe Aceh Darussalam Province and the Islands of Nias of North Sumatra Province;
 - b. to coordinate the process of compiling and formulating correct policies in cooperation in order to promote rehabilitation and reconstruction of the regions and the life of people of Nanggroe



Aceh Darussalam Province and the Islands of Nias of North Sumatra Province;

- c. to execute synchronization, integration, evaluation and cooperation in conducting rehabilitation and reconstruction programmes;
- d. to compile the concept on role sharing among actors of rehabilitation and reconstruction of the region and the life of people of Nanggroe Aceh Darussalam Province and the Islands of Nias of North Sumatra Province;
- e. to compile the concept on mechanism to mobilize all funding sources (APBN, APBD Provinsi/Kabupaten/Kota and Donor Support) and their distribution so that they become more transparent, effective, participative and accountable;
- f. to prepare quarterly report to Advisory Team regarding the implementation of duty and responsibility of Joint Secretariat;
- g. to resolve any problems correlated with conflicting policies between the Agency of Rehabilitation and Reconstruction of the Regions and the Life of People of Nanggroe Aceh Darussalam Province and the Islands of Nias of North Sumatra Province and Government of Aceh and all districts/cities across Nanggroe Aceh Darussalam Province.
- h. to prepare data and information required to achieve the objectives of all activities set forth by Executive Team;
- i. to compile initial draft of every concept required in the implementation of duty and responsibility of Joint Secretariat;
- j. to seek immediate solution for every technical problem emerging in the implementation of duty and responsibility of Executive Team;
- k. to use all resources necessary to ensure the success of Joint Secretariat in implementing its duty and responsibility.

FIFTH : In the implementation of operational and administrative activities of joint Secretariat, Executive Team shall appoint Operational and Administration Staff with main tasks:

- a. to prepare work schedule for all Joint Secretariat activities;
- b. to conduct secretarial functions (correspondence, archival, communication, and the like);
- c. to collect and process data and information;
- d. to distribute letters and publication materials and the like;
- e. to look after the security of the office and all personnel;
- f. to run and maintain the office;
- g. to execute other tasks assigned by Advisory Team and Executive Team of joint Secretariat.

SIXTH : Joint Secretariat in executing its duties as referred to in SECOND dictum is under provision of Head of Executive Agency for the Agency of Rehabilitation and Reconstruction of the Regions and the Life of People of Nanggroe Aceh Darussalam Province and the



Islands of Nias of North Sumatra Province and Governor of Nanggroe Aceh Darussalam.

- SEVENTH : Any cost occurring from the issuance of this Joint Decree is paid for by the budget of Agency of Rehabilitation and Reconstruction of the Regions and the Life of People of Nanggroe Aceh Darussalam Province and the Islands of Nias of North Sumatra Province and Governor of Nanggroe Aceh Darussalam.
- EIGHTH : This Decree is effective since the date of its enactment and shall be retroactive started on the date of January 1, 2008.
- NINTH : This Decree is effective until the date of December 31, 2008.
- TENTH : If any mistake is contained by this Joint Decree, amendment shall be made accordingly.
